

Guelph Youth Music Centre (GYMC) Vaccination Policy

Introduction:

The Guelph Youth Music Centre (the “GYMC”) is committed to maintaining a healthy and safe environment for everyone who attends the GYMC in the wake of the COVID-19 pandemic. In our day-to-day facility operations, we are responsible for protecting all students, participants, parents, teachers, volunteers and staff. For this reason, it is critical that the GYMC take any and all precautions to protect against the spread of COVID-19. Therefore, we have implemented a mandatory COVID-19 Vaccination Policy.

Scope of Policy:

This policy applies to everyone, 12 years of age and older, who enters the premises of the GYMC, located at 75 Cardigan Street in Guelph (the “GYMC Facility”). Please read the policy carefully.

Please note that the GYMC has also implemented a COVID-19 vaccination policy for the GYMC staff. Importance of Vaccination:

Vaccination against COVID-19 is a key part of our overall strategy and commitment to maintaining a healthy and safe centre in light of the pandemic. Although knowledge about the virus continues to evolve, vaccination appears vital in curbing its spread based on the information we have now. Compliance with this policy is essential because current consensus on the virus suggests, among other things, that:

- COVID-19 and its variants are highly contagious;
- COVID-19 and its variants spread mostly among people who are in close contact in an indoor setting;
- A person who has the virus may not have any symptoms but may still spread COVID-19 and its variants;
- COVID-19 and its variants can cause serious and long-term ailment or be fatal.
- Currently, a significant majority of those with COVID-19 who have died or require hospitalization are not fully vaccinated.

For these reasons, public health experts recommend that individuals be vaccinated at their earliest opportunity. We need your full cooperation and compliance with these measures to make them effective in this new situation.

Vaccination Measures:

It is the policy position of theGYMC to ensure everyone entering theGYMC Facility is vaccinated against COVID-19, as recommended by the Ministry of Health and Provincial Health Officer. Subject to the exemptions enumerated in this policy, effective immediately and until further notice, theGYMC requires you to obtain full vaccination for COVID-19 prior to engaging in any lessons (single or group), events or any other business that brings you into theGYMC Facility. All those wishing to enter must provide complete and accurate information for the purpose of satisfying the proof of identification and vaccination requirement in O. Reg. 364/20.

Any individual wishing to enter the Facility must present:

- proof of identification such as driver’s license or health card, AND
- proof of being vaccinated – documentation issued by the Ontario Ministry of Health containing the requisite QR code, OR
- proof of being vaccinated – other province or territory or international equivalent proof indicating individual immunization status verification

You must present your verification QR code documentation to your program or event leader, or upon entry to the building. A printed copy of your verification documentation with QR code is acceptable.

Should an individual choose not to share the required information to enter the Facility, they will not be permitted to enter, except through accommodation.

Accommodation:

TheGYMC is committed to accommodating medical conditions and creeds and will take all reasonable steps to accommodate individuals who cannot be vaccinated based on these reasons.

The method of accommodation will be determined on a case-by-case basis, having regard to the recommendations of medical specialists and public health officials.

If you request an accommodation via the Confirmation of COVID-19 Vaccination Form, please speak directly to your program/event leader orGYMC office manager or executive director, who will be able to address your accommodation request.

You will be asked to provide the relevant form signed by a medical professional, or in the case of creed, an exemption request sworn and affirmed by a Commissioner of

Oaths. Please note that with respect to the COVID-19 pandemic, the **Ontario Human Rights Commission's (OHRC)** position has been that a singular belief or personal preference against vaccinations and/or masks is not protected on the ground of creed under the *Code*.

TheGYMC may impose some or all of the following protocols and procedures, among others, to accommodate unvaccinated individuals while protecting all others who engage at theGYMC:

- Before entering the building, wear a (minimum 2-ply) face mask at all times, covering the nose, mouth and chin.
 - Note: Gators, face shields; bandanas, etc. are not acceptable face coverings;
- Sanitize hands upon entering the building;
- Avoid greetings that involve physical contact such as shaking hands or hugging;
- Ensure a 2-metre distance from others when inside the building;
- Do not share equipment or instruments;
- Do not leave personal items at theGYMC.

Administration of This Policy:

Each tenant organization and Renter is responsible for collecting and maintaining vaccination information and verification, including contact information, from everyone 12 years and older who will be entering theGYMC under their auspices.

TheGYMC expressly reserves the right to change, modify or delete portions of this policy without notice. This policy was developed in cooperation with the Board of Directors of the Guelph Youth Music Centre.
